

California Privacy Policy

Design Dojo LLC (“Company,” “we,” “our,” or “us”) respects your privacy. This California Privacy Policy supplements our general [Privacy Policy] and applies solely to California residents in accordance with the California Consumer Privacy Act (CCPA) and California Privacy Rights Act (CPRA).

1. Categories of Personal Information We Collect

In the last 12 months, we may have collected the following categories of personal information:

A. Identifiers	Name, email address, IP address, online identifiers	Yes
B. Customer Records	Billing address, shipping address, phone number	Yes
C. Commercial Info	Records of products or services purchased	Yes
D. Internet Activity	Browsing history, search history, interactions with our website	Yes
E. Geolocation Data	Approximate location derived from IP address	Yes
F. Inferences	Preferences, behavior, or trends inferred from other data	Yes

We do not collect:

- Biometric data
- Sensitive personal information beyond basic contact/payment data
- Government-issued identifiers (unless required by law)

2. Purpose of Collection

We collect personal information for the following purposes:

- To provide and improve our products and services
- To process transactions
- To respond to inquiries and customer service requests
- To personalize content and user experience
- To analyze website usage and improve functionality
- To comply with legal obligations

3. Sources of Information

We collect personal information from the following sources:

- Directly from you (e.g., contact forms, purchases)
- Automatically through your use of our website
- Service providers and third-party analytics tools

4. Sharing of Personal Information

We do not sell your personal information. We may share your information with:

- Service providers (e.g., hosting, payment processors, analytics)
- Affiliates and contractors for business purposes
- Law enforcement or regulators when required by law

We require all third parties to maintain the confidentiality and security of your data.

5. Your California Privacy Rights

As a California resident, you have the following rights:

a. Right to Know

You have the right to request that we disclose:

- The categories of personal information we collect
- The sources of collection
- The business or commercial purposes for collecting it

- The categories of third parties with whom we share it
- The specific pieces of personal information we hold about you

b. Right to Delete

You may request we delete your personal information, subject to certain legal exceptions.

c. Right to Correct

You may request correction of inaccurate personal information.

d. Right to Opt-Out of Sale or Sharing

We do not sell or “share” personal data for cross-context behavioral advertising. If that changes, we will update this policy and provide a method to opt out.

e. Right to Non-Discrimination

We will not discriminate against you for exercising your privacy rights.

6. Submitting a Request

To exercise your rights under the CCPA/CPRA, you may:
